As a volunteer, we would like to advise you of the following conditions:

1. That the Principal is responsible for all volunteers. All volunteers are subject to the direction of the principal at all times.
2. Volunteers shall at all times act in accordance with Division and School policies and procedures.
3. Applicants for volunteer positions must submit a criminal record check and a child welfare information services (CWIS) check. Volunteers who do not directly supervise students, and where a staff member is present and in attendance at all times, will not be required to submit record checks.

4. That confidentiality is of the utmost importance in the school setting in order to ensure that the dignity and worth of students, parents, volunteers and school staff is honoured.
5. That any information collected, used, generated, and stored by the St. Thomas Aquinas RCSR D #38 including student, instructional, financial, or administrative information is strictly confidential and is to be used only in the performance of volunteer duties.
6. That you may not disclose, communicate, publish, take, alter, copy, interfere with, or destroy any information unless you are specifically authorized to do so by the teacher or principal.
7. That the teaching and administrative staff are responsible for student learning and discipline.
8. That school administration, teaching and support staff have specific roles to play and it is important that the staff of a school operate as a team.
9. That any failure to comply with these conditions or St. Thomas Aquinas RCSR D Board policies may result in your termination of your positions as a volunteer.
